Request for City Electrical Service

A resident proposed that Parkside be included on the City electrical grid versus the "Whidbey" grid.

The Puget Sound Energy expert is on vacation until February 16. Need to follow up when the expert is available.

According to PSE, a recloser unit will be installed on a pole near the entrance to Lakeside Industries on Havekost Road by the end of April. This unit will improve system reliability. **Item Closed**

The City cleaned up the detention pond for Westwood. Need to contact the City of Anacortes to determine if they will clean up Parkside. – **Johnson**. An update will be provided next meeting.

Tree in Common Area

A homeowner expressed concern about a tree in the common area that could likely create a hazard. The tree will be inspected by a qualified arborist to determine if any action is needed.

Two independent arborists confirmed that the tree should be removed. The homeowner offered to pay half the expense. The Board approved releasing funds to cover the half of the expense.

Street Repair (Shelby Court)

Sink holes identified in Parkside are scheduled to be repaired this summer. Need to request that the front entrance cracks in the asphalt be repaired at the same time.

The city was requested to make the repairs and the Board will follow up.
