Approval of Minutes

The minutes of the regular meeting held March 21, 2007 were approved by email and have been posted on the website.

Secretary/Treasurer's Report:

The checkbook balance as of April 17, 2007 is \$9,020.48.

The reserve in the form of a CD is \$3,000.00.

The total annual budget is \$11,010.00.

The budget as of March 31, 2007 has a favorable variance of \$ 120.83.

Old Business

Adequacy of Reserves

There was discussion regarding the reserves and whether there should be more substantial reserves for specific elements such as the pavement for the private access to Lots 8, 9, and 10, PII.

The 2007 reserve of \$3,000 has been separated from the checking account and placed in a CD at Skagit State Bank.

Pavement Crack in Lake Park Drive

Tom has talked to the City Public Works Department and is awaiting their response.

Lot 3, PII Alder Tree Problem

Tom Johnson and John Lindsay looked at tree behind Lot 3 that is leaning and possibly decayed. They are now waiting for the owner's health to improve to look at it with John Lunsford from the city.

Paint Color Approval, Lot 12, PI

The owners indicated that they want to paint their house a different color, however, no paint samples were submitted for review at this meeting.

Lot 32, PI Tree Removal Request

Tom Johnson has already looked at the trees in question and given approval. The trees are damaged/diseased and are on the Williams' property. They do not want to remove the trees (one in front and one in back), but are apprehensive because of the damage that they sustained in last December's blow. They will defer to the recommendations of a tree service.

Paint Color Approval, Lot 35, PI

Color samples were submitted and approved. The Trim will be Columbia Premium Pro Plus, Ext. white semi gloss, 02-252-WB, Acrylic Latex.

The Siding will be Sherwin-Williams, Pro-Mar, Ext. beige - Low sheen, 8290-P122, (base) B30W00451, extra white 640510111.

New Shed for Lot 31, PI

A request for a new shed was approved. The shed will be in the back yard and is to be 10' x 12' and sided, painted, and roofed to match the house. It will replace two plastic sheds.

Lot 9, PI Tree Topping

The owner's requested permission to top two trees that are felt to be in danger of blowing over.

Tom will review with John Lunsford inasmuch as it may be better to thin them.

Lot 14, PII Green Belt Concerns

The owner was concerned about the extent of the clearing of the green belt behind his house by his neighbor.

Tom Johnson contacted the neighbor who indicated that he was only clearing some blackberries and some trash a previous over had dumped in the green belt.
